

# **University Research Committee**

Summary of Activities, 2015-2016 Academic Year

Six 90-minute meetings were held. Professor Caroline Wagner was elected Chair, and Professor Bala Balasubramanium served as Vice Chair. The list of committee members serving during this academic year is attached.

#### I. Advising

- Intellectual Property. Provided review and comments to the University Senate
  Intellectual Property, Patents, and Copyright Committee and the Fiscal Committee on
  changes around intellectual property and ownership of the results of research, Chapters
  5 and 13.
- Role of Committee. Informed the Committee on Academic Affairs about the activities of the University Research Committee.
- University Centers. Reviewed the application and commented on two proposals to establish University Centers.
- Committee Membership. Provided the Senate Cabinet with a list of candidates to invite to serve on the committee for the next academic year.
- Formally advised the Office of Research on four cases of research misconduct.
- Provided input on the review process around updates to the chemical hygiene plan that led to positive changes for the research process.

### II. Oversight

- Discovery Themes. The committee requested and received a briefing by Dr. Michael Boehm on research progress under the Discovery Themes. Additional input may be requested.
- Institutional Review Board. Continued to monitor progress on the IRB review process changes and improvements. Satisfied with the rate of improvement to date and considering issuing a statement to the university research community noting the actions taken to improve the process.
- Rewarding interdisciplinary research. Requested and received a briefing by Vice Provost
  Kay Wolf on progress towards enhancing metrics for faculty research activities. The
  committee will provide input on this issue early in the next academic year.

## III. Service

- Hosted two open meetings at the Research Commons, one on the problems associated with open access publishing, and one on the question of measuring and reviewing collaborative research activities.
- Initiated inquiries into the need for "Expert Search" capabilities at Ohio State. Will continue on this issue in the next academic year.
- Drafted a Code of Conduct for the Research Committee to forward to the Senate Office.
