Dear Eileen,

The Graduate School has reviewed the degree title change request for the MA in Slavic and East European Studies. Generally, the Graduate School has no concerns and it can go straight to CAA for review; however, the following considerations were noted:

- 1. The program is suggesting a new plan code. The Registrar's Office has the final say on any plan change. If the plan code is changed, then please be aware that current students will be under the old plan name. Historically, the Graduate School has allowed current students to make the choice to graduate from the program name in which they were admitted. The program can decide whether to notify current students about the switch or if current students will remain under the old plan.
- 2. Even though this is a degree title change, as a point of clarification, the degree title does not affect the name of the program. If you would also like the program name to change, then the description in SIS (known as the long code) will need to be updated. Please consider noting this in your letter to CAA.
- 3. The letter only mentions the SLAVEES-MA program. If the program would also like a similar change for the SLAVEES-PH program, please note this in your letter to CAA and complete a second CCGS Title Change form.
