CSA interacted closely with COAM, Steering, and Rules.



I. Council on Student Affairs

Purpose

The Council on Student Affairs (CSA) is broadly responsible for overseeing the student experience from a co-curricular perspective. CSA serves as the principal link between students, the student governments, the faculty, and administration to encourage a sense of community and improve the quality of student life on campus. The best interests of all students are at the forefront of the Council's mission. CSA's primary responsibilities include:

- Administer and create regulations pursuant to the Rules of the University Faculty, the bylaws, and the statutes, insofar as they pertain to the quality of student life
- Approve policies that govern the registration, rights, privileges, and obligations of student organizations, such as fraternities and sororities, student publications, and student governments
- Initiate reviews of any issue that is relevant to the student co-curricular experience
- Initiate recommendations and review proposals regarding policies that may affect student life quality
- Review, allocate, and administer the Student Activity Fee
- Review the Student Code of Conduct
- Advise the Senior Vice-President for Student Life on the services, programs, and administration of the Office of Student Life
- Advise other university departments and administrative units regarding proposed changes within those departments and units that may affect student rights and responsibilities

Overview

This year, CSA worked to finalize and implement the Student Code of Conduct completed during the 2022-2023 academic year. CSA also worked on changing and updating the method of hearing reports and completing advocacy. In previous years CSA heard from a fixed number of the same departments and areas, the current plan allows CSA to choose which areas they want to interact with based on the interests of the current committee. Additionally, CSA updated its Procedures, bringing them in line with current operational practices.

The Issues Committee worked on issues within the Housing and Residence Education (HRE) Department, Transportation and Traffic Management Department, and Dining Services. Within HRE, they worked on issues surrounding housing accommodations, safety on campus, and the common room spaces. Within Dining Services, they worked on food quality, dietary restrictions, and healthy and nourishing food option issues. For Transportation and Traffic Management, they worked on safety within transportation, issues for commuter students, and different modes of transportation. Lastly, they worked with CGS to implement gender neutral restrooms in on campus buildings.

Allocations gathered, reviewed, and implemented changes for Student Organization Guidelines and procedures. They also completed important work in administering the 4.5M Student Activity Fee (SAF) and approving Programming Funding requests for the entire year.

II. Issues Committee

This year the Issues Committee focused on several topics including Transportation, Dining Services, Residential Education, and Legal Services. Leaders from each University department in charge of these areas were invited to CSA Issues meetings. Leaders from the Transportation and Traffic Management (TTM), Dining Services, Housing and Residence Education, and Student Legal Services departments all gave talks at either Issues Subcommittee meetings or CSA Meetings. These talks lead to a better understanding of challenges faced by students and more insight on how the University is making efforts to better address these issues. These conversations allowed CSA Issues to highlight areas that could be improved on and relay feedback back to the OSU body.

The Issues subcommittee met 12 times during the 2023-2024 school year, with a total time of around 18 hours. Additionally, the co-chairs met separately on a weekly basis.

III. Allocations Committee

The CSA Allocations Committee is charged with administering the distribution of the Student Activity Fee, which generates roughly 4.5 million/year and covers. As laid out in the 2022-2025 SAF review, Funding was distributed between various beneficiaries, including the Ohio Union Activities Board, Discount Ticket Program (D-Tix), Student Organizations, Signature Events, Student Governments, Buck-I-SERV, and Pay It Forward, as laid out in the 2022-2025 SAF Review: 2022 April SAF Review.docx.

Undergraduate, graduate, and professional student organizations may submit programming and operating applications received and reviewed according to CSA's Student Activity Fee distribution guidelines. For 2023-2024, New & Re-Established Student Organizations could apply for up to \$3,000/year for their programs while Established Student Organizations could apply for up to \$4,500/year. Student Organizations could also apply for Operating Funds up to \$500/year to help cover administrative costs. Prior to the 2023-2024 funding year, the Allocations Subcommittee identified multiple areas in the Programming and Operating application process with room for improvement through hearing directly from multiple student organization leaders and lived experience reviewing applications. Many changes were drafted and passed during a Full Council vote. Below are the changes for 2023-2024:

- 1. The Operating Funds yearly limit increased from \$200 to \$500/year for all student organizations.
- 2. The Programming Funds yearly limit increased from \$3,000 to \$4,500/year for Active-Established organizations and from \$2,000 to \$3,000/year for Active-New/Re-established I and II organizations.
- 3. Programming Funds no longer has a percent limitation on the food/beverage expense category.
- 4. Programming Funds now allow consumable supplies to be reused for future events and organizational functions held within the same funding year.
- 5. Programming Funds has a revised category now named Incentives/Take-Aways with updated guidelines.
- 6. Programming Funds has updated guidelines for maximum attendee admission/ticket costs based on the length of program time.
- 7. Invoices can be paid directly to any Ohio State internal vendor with Programming Funds.

The group reviewed 1359 Programming Requests during Fall 2023 and Spring 2024, representing a 97.53% increase from the 688 received during 2022-2023. Of these requests, 1086 were approved, either initially or through the appeals process, to host a Student Activity Fee-supported event. Approved requests totaled 987k or an average program request of \$908.84. The group also oversaw the distribution of 640 operating fund requests at a total of 173k/an average request amount of \$270.66. Due to the stark increase in Programming Fund application volume, the Subcommittee updated its meeting procedures. The committee set

three meetings for smaller groups of four members to review applications. These small groups flagged necessary programs for full committee review. This updated process allowed for a much quicker and better distribution of work than previous processes, leading to shorter turnaround times. These groups met a collective 60 times for one-hour meetings over 2023-2024. Additionally, the full Allocations Subcommittee met 16 times for 24 hours across the Fall and Spring semesters for a one-hour and thirty-minute meeting to discuss and vote on various other Student Activity Fee-related matters.

IV. Code of Student Conduct Review

CSA's Code review was originally meant to be completed during the 2021-2022 academic year, but due to the COVID-19 pandemic, CSA voted to push the review back to the 2022-2023 academic year on September 27, 2021. CSA also voted to create the Code of Student Conduct Audit Committee to collect data and draft suggestions for the review the following year. The Audit Committee met on April 29, 2022. The 2021-2022 Chair of CSA, Caroline Karwisch, chaired the meeting. The Audit Committee collected data and suggestions and passed them along to the Code of Student Conduct Review Committee to help start the review. The Code of Student Conduct Review Committee met a total of 16 times (3 during Fall 2022, 12 during Spring 2023, and 1 during Summer 2023) to review the Code.

Highlights of the Code Review:

- Made fixes to inconsistencies on verbs, nominalization, and grammar throughout the Code
- Updated policy numbers and names throughout the Code
- Added an existing accessibility statement to make clear that students are eligible for accommodations from the ADA's Coordinator's office
- Implemented a definition change, introduced and approved by COAM on April 25, 2023, of quorum to decrease the number of voting members from four to three due to issues with getting four voting members to attend hearings.
- Added animal abuse as prohibited conduct
- Added requirement for a process document on cases involving student organizations was added
- Changed UCB and COAM membership requirements to remove GPA requirements for grad/prof students, no "semester or year" as student requirement
- Expansion of introduction to include the Shared Values Framework and honor pledge
- Clarification on when the use of Artificial Intelligence constitutes academic misconduct
- Clarified the definitions of calendar and business days
