Senate Fiscal Committee Annual Report Fiscal Year 2013

The Senate Fiscal Committee had a very active and full calendar this year. Major projects included a Program Fiscal Review of the Office of Student Life, a review of the Study Abroad funding structure, a review of the OSU Online funding structure as well as review and analysis of components of the FY 14 budget.

Recommendations and reports included:

- Program Fiscal Review of the Office of Student Life the report focused on four major issues
 - The new debt service obligations brought on by Student Life's planned North Residential
 District plans and its affect the cost of housing to students and in turn the University's
 competitiveness in attracting students in future
 - Staffing plans for future needs and how can potential overlaps in administrative services—in information technology, purchasing, and facilities maintenance—be best managed for cost savings without significant negative impact upon the student experience
 - Fiscal plans in place for adequate ongoing maintenance, refreshment, and replacement of Student Life facilities (RPAC, Ohio Union, Lincoln/Morrill Towers, and others)
 - The Second-year Transformational Experience Program (STEP) review of planning process and total financial impact fully understood? Can the campus community be engaged sufficiently in the relatively brief planning period? Is its evaluation process sound? What are the long-term sources of funding? Is the STEP effort financially sustainable?
- Reviewed and provided official feedback on the Office of Business and Finance's Strategic Plan
- FY 14 Benefit Rates
- FY 14 Overhead Rates
- FY 14 POM Rates
